Re: **Postponement of the 2020 CASF Infrastructure Application Deadlines**

In Decision (D.) 18-12-018, the California Public Utilities Commission (CPUC) established timelines for submission of applications for the CASF Infrastructure Account. Due to the COVID-19 (coronavirus) public health emergency and in response to some stakeholders' requests, the CPUC has made the difficult decision to postpone the 2020 CASF infrastructure application deadline. Pursuant to Rule 16.6 of the Commission's Rules of Practice and Procedure, I, as Executive Director of the CPUC, authorize that the deadline for applications be moved from April 1 to May 4, 2020, and all subsequent deadlines are moved back by five weeks. The changed deadlines apply only to 2020. The timeline for future years will follow D. 18-12-018.

The resulting revised timeline for this year is displayed below:

Deadline for publishing Draft Resolutions recommending Project Approval	November 13, 2020
