Mono County has 5768 households of which 5627 are underserved and 141 are unserved. Schat Communications will interconnect these local communities to the California Broadband Corporation's middle mile fiber backbone at 7 points of presence in Mono County.

Inyo County covers 10,181 square miles.

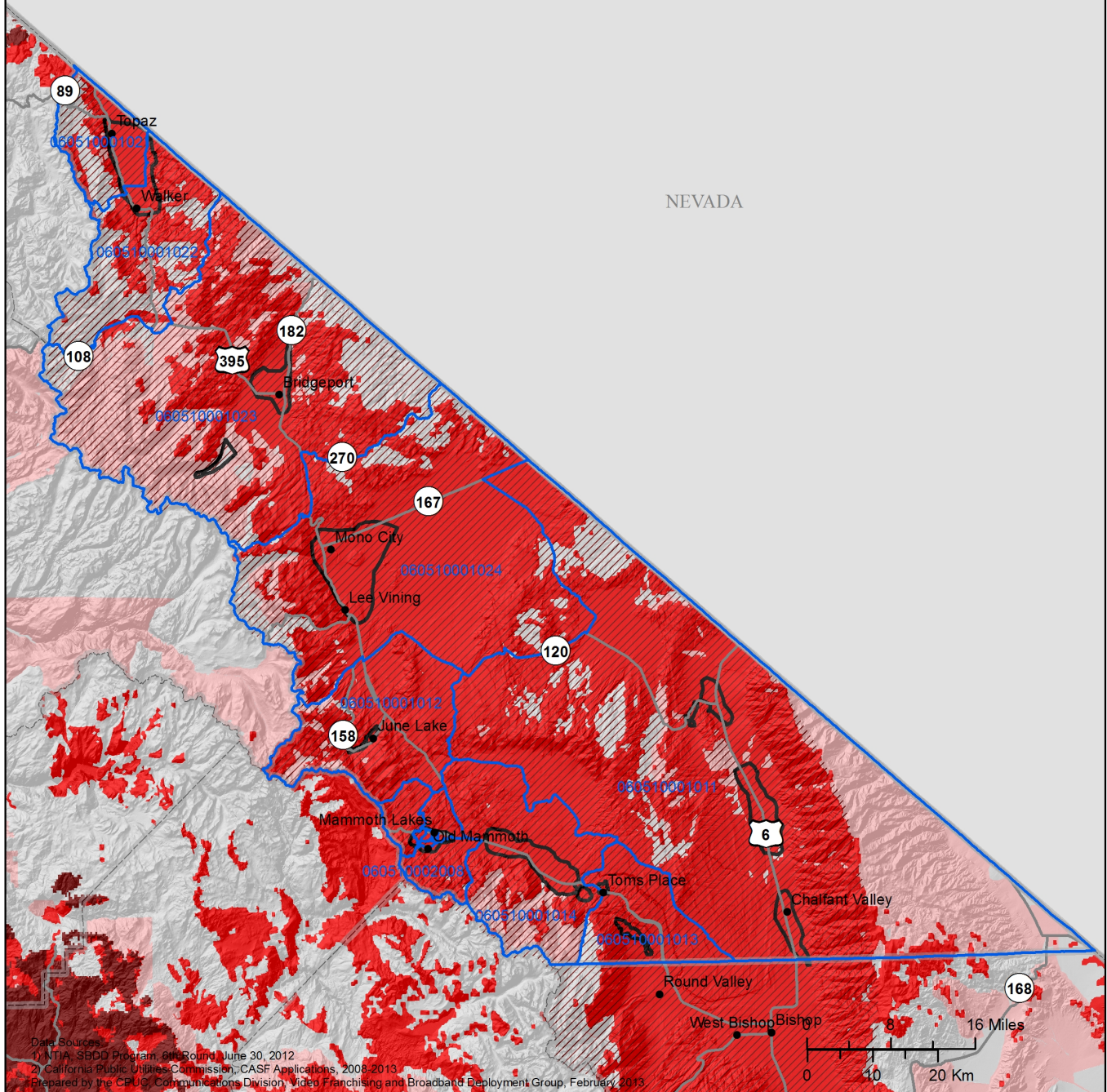
