I. Summary

The Central Coast Broadband Consortium (CCBC) enthusiastically endorses President Peevey's Alternate Resolution T-17429 which proposes to fund the Sunesys, LCC Connected Central Coast Unserved and Underserved Broadband Project (Sunesys project) in the amount of \$11,028,245 via the California Advanced Services Fund (CASF). CCBC is the CASF-funded consortium representing California's central coast region, which includes the Counties of San Benito, Monterey and Santa Cruz.

II. The Sunesys middle mile proposal exactly matches areas of the region with the greatest last mile needs

At the request of Communications Division staff, CCBC conducted an analysis of our three-county region in order to develop a priority list of areas that are eligible for CASF funding. This work was unrelated to the Sunesys project, although it relied on much of the same data that was used in developing that proposal.

Beginning with CASF eligibility criteria, we ranked 67 communities in Monterey, San Benito and Santa Cruz Counties on the basis of number of people, population density, percentage of community eligible for CASF support, household income and number of community anchor institutions.

The ten communities with the highest priority for CASF support, taking into account CASF eligibility, are all either directly served by the Sunesys proposal – Soledad, Gonzales, Chualar, Castroville – or are just south of its southern terminus – Greenfield, King City, San Lucas, San Ardo, Pine Canyon – or just to the east, in the case of Aromas.

In just these ten communities, 77,004 people live in 15,756 households according to the 2010 U.S. census. Excluding the Aromas area, which is more rural and sparsely populated than the nine Salinas Valley communities, population density exceeds 2,000 people per square mile, an average of five people live in each home and household income averages less than \$48,000 per year. These communities also suffer from high unemployment, high poverty levels and poor education.

III. Widespread community support confirms statistical analysis and dire need

Appendix A, attached below, contains more than 20 letters of support submitted by elected representatives, senior officials and members of the business community. Other organizations and individuals have submitted letters of support independently. Support for funding the Sunesys project at the 83% level proposed in President Peevey's Alternate Resolution T-17429 is unanimous.

Monterey County Supervisor Simon Salinas – who represents the large, broadband-deprived communities in the southern Salinas Valley that are at the top of the CCBC priority list – has worked with the Sunesys team to help create a proposal that addresses this unfair and unsustainable digital divide. Supervisor Louis Calcagno, who represents the priority communities to the north, has likewise endorsed the project, as have leaders from the incorporated cities of Gonzales, Soledad, Greenfield and King, and the Association of Monterey Bay Area Governments. These community leaders and organizations are on the front line of the battle to create jobs and improve health and public safety for all residents within the project area, a battle that modern broadband infrastructure can help win.

Monterey County Superintendent of Schools Nancy Kotowski has written of the disadvantages suffered by students in the project area: injustices that greater access to broadband infrastructure can help rectify. California State University Monterey Bay and its Institute for Innovation and Economic Development, which also serves students from the project area, eagerly await the educational and employment opportunities it will bring.

Business leaders and employers from organizations serving the project area – the Salinas United Business Association, the Salinas Valley Chamber of Commerce and the Monterey County Business Council – have endorsed the proposal and look forward to the opportunity to use modern broadband infrastructure to create the kind of prosperity in the Salinas Valley that wealthier areas of our region take for granted. Their colleagues in the venture capital community and the Monterey Peninsula Chamber of Commerce are just as supportive, knowing that equitable economic development benefits all.

This realization that everyone's prosperity depends on social and economic equity and equal access to opportunity is universal in our region, as other letters of support amply attest. We are united in our support of the Sunesys project.

IV. CASF subsidy will make broadband service affordable and abundant in the Salinas Valley

Alternate Resolution T-17429 provides that middle mile fiber and wholesale bandwidth from the Sunesys project will be available at rates comparable to those found in Silicon Valley for at least five years. Further, Sunesys has committed to limiting future

prices increases in Year 6 and beyond to the rate of increase of the Consumer Price Index¹.

We commend Sunesys for creating a level broadband playing field for the people of the Salinas Valley for many years into the future and we ask that Alternate Resolution T-17429 be amended to document this ongoing rate increase commitment as a vital and just public benefit that further supports its approval.

V. Conclusion

The Sunesys project is the cornerstone of our region's plans for improving broadband access and bringing the benefits of twenty-first century technology and prosperity to tens of thousands of people who live in the economically depressed Salinas Valley and in other unserved and underserved areas of California's central coast. We thank the Commission for its kind consideration and respectfully request the approval of President Peevey's Alternate Resolution T-17429.
